ANNUAL REPORT 2017

The Ministry of Health has been contracting with the College of Physicians and Surgeons of Saskatchewan (CPSS) since 2001 to operate the Opioid Agonist Therapy Program on its behalf. The object of the Program is to administer the methadone exemption process for Saskatchewan physicians and to ensure the safe and appropriate use of medications used as opioid agonist therapy. Currently, Dr Morris Markentin is the program manager, and Nicole Mclean provides administrative support. The Program name was changed from Methadone Program to Opioid Agonist Therapy Program in 2017 to be inclusive of the buprenorphine/naloxone (Suboxone) preparation.

In 2017, 19 new Saskatchewan prescribers applied for and received a methadone exemption from Health Canada. Six of these were for addiction, and 13 were for pain. Currently, there are 133 Saskatchewan physicians who hold a methadone exemption.

- 22 have an exemption for addiction
- 65 have an exemption for pain
- 46 hold an exemption for both indications

A list of practitioners authorized to prescribe methadone in Saskatchewan is contained in *Appendix 1*. This list indicates if the practitioner can prescribe for addiction, pain or both indications. It also lists their practice location.

In addition to methadone, the College has set a standard for the prescribing of buprenorphine for addiction (Regulatory Bylaw 19.1). Currently, 57 physicians meet the requirements to prescribe. A list of practitioners authorized to prescribe buprenorphine/naloxone for addiction in Saskatchewan is contained in *Appendix 2*.

In 2017, one methadone practice audit was performed.

The Opioid Agonist Therapy Program continues to update the Saskatchewan Opioid Substitution Therapy Guidelines and Standards for the Treatment of Opioid Addiction/Dependence as appropriate. The last update was made June 2017 to address the Health Canada changes to the Section 56 Class Exemption for Practitioners Prescribing Methadone to Inpatients in a Hospital Setting. The Opioid Agonist Therapy Program again offered its annual Opioid Substitution Therapy conference on April 29 and 30 in Saskatoon. The conference had 15 speakers, who spoke on 17 topics. The number of attendees was 176, 90 of which were physicians. An overview of the event is provided in *Appendix 3*.

- ^{4.} The CPSS OST Standards and Guidelines indicate that Metadol tablets are not to be used for addiction. However, there may be the rare circumstance in which Metadol tablets may be used for addiction. The majority of the individuals in this category should be representative of those receiving methadone for pain. Metadol is also available as an oral suspension.
- ^{5.} In 2017 there was a methadone powder shortage and consequently some addiction patients may have received Methadose for addiction. Methadose is not listed on the Saskatchewan Drug Formulary, so it is rarely used for this indication, and rarely used in general.

Overall, in any given month, there are approximately 3400 patients receiving methadone for addiction in Saskatchewan.
