This letter is to inform you that the substance known as Furanyl UF-17 (NOT controlled under the Controlled Drugs and Substances Act) was found in exhibit BC0157051 also containing fentanyl, heroin, caffeine, and phenacetin. This exhibit was received in our laboratory on Dec 18, 2020. According to our records, this exhibit met the following criteria:

- ☐ This substance newly encountered in your community is known to be associated with overdoses or deaths:
- ☐ This substance is presented as a new form of exhibit that individuals may be unaware they are consuming; or
- ✓ This substance is so novel that limited information is available on its safety.

This letter is to inform you that the substance known as **ethyl-heptedrone and 3,4-methylenedioxy-N-benzylcathinone (BMDP)** (both are controlled under the Controlled Drugs and Substances Act) are present in exhibit BC0157228, also containing alprazolam and 4-anilino-1-boc-piperidine. This exhibit is in the form of a counterfeit alprazolam tablet with markings "S/90/3". This exhibit was received in our laboratory on December 23rd, 2020. According to our records, this exhibit met the following criteria:
