

EXAMINER RECRUITMENT

We are seeking physicians to participate as physician examiners (PEs) in the September 2019 National Assessment Collaboration (NAC) exam session. It is thanks to the efforts of our volunteers, including physician examiners, that we are able to hold high-stakes clinical examinations across the country, and ensure excellence in the evaluation of International Medical Graduates (IMGs) for entry into residency.

Examination format

This examination consists of a series of <u>clinical stations</u> including pilot stations that do not count towards a candidate's total score.

Examination date and time

We are looking for PEs who are available on Saturday, September 14th &/or Sunday, September 15th, 2019 (full days).

Mandatory for all physician examiners

- Completion of a pre-exam online orientation as well as a condensed exam day orientation with an online scoring review
- Acceptance of the MCC's Code of Business Conduct
- Cell phones or other electronic devices are not permitted inside the stations on exam day
- All examination materials related to the NAC examination are confidential and the copyright of all examination materials belongs exclusively to the Medical Council of Canada (©MCC/CMC). PEs may not discuss or disclose examination content with others at any time, in any form during or after the examination.

Physician examiner basic requirements

- Physicians must be senior residents (PGY 4+), hold an LMCC and be practicing medicine in Canada with recent experience supervising clerks and/or experience as an examiner at this level of training. They must be registered and in good standing with a Medical Regulatory Authority (MRA) in Canada.
- All PEs must attempt to avoid any actions or situations that could result in a conflict of
 interest. Where a PE identifies an actual, perceived or potential conflict of interest (whether
 or not the examiner is the subject of the conflict of interest), the examiner must promptly
 report the conflict of interest to the MCC via coi@mcc.ca
