

## **English Language Proficiency**

## AN APPLICANT MUST:

- 1. Have taken <u>IELTS academic version</u> within the previous 24 months and achieved a minimum of 7.0 in each of the components (*Note: IELTS does not offer sub-tests on their examinations*); *or*,
- 2. Have taken <u>OET-medicine version</u> within the previous 24 months and achieved a minimum grade of B in each of the four subtests (*Note: OET offers sub-tests. The CPSS may accept a subtest if it is obtained within the same 24 months as the original OET-medicine exam was taken and a minimum grade of B was obtained. For example: Exam taken May 18, 2022 is valid until May 18, 2024. Any subtest taken between those dates, with a minimum grade of B, may be considered); or,*
- 3. Have taken <u>CELPIP</u> General within the previous 24 months and achieved a minimum grade of 9 in each of the four skill sections (*Note: CELPIP does not offer sub-tests on their examinations);* or
- 4. Have taken <u>undergraduate medical education in English</u> in Canada, the United States or one of the other countries that is identified by the Federation of Medical Regulatory Authorities of Canada (FMRAC) as having English as a first or native language; **or**,
- 5. Be currently <u>enrolled in a postgraduate medical education program</u> in the United States or Canada or one of the other countries that is identified by the FMRAC as having English as a first and native language and the applicant previously met one of the requirements of 1, 2 or 3 in order to enter into that postgraduate training program; **or**,
- 6. Be <u>currently in practice</u> in Canada or the United States or one of the other countries that is identified by the FMRAC as having English as a first or native language and the applicant met one of the requirements of 1, 2 or 3 in order to be admitted to postgraduate training or practice in that country; **or**,
- 7. Demonstrated <u>other proof of English proficiency</u> acceptable to the Council (see page 2 for acceptable evidence).

**\*\* Note:** Canadian applicants with medical education from the University of Quebec, Montreal, Sherbrooke, Laval, and the University of Ottawa (French stream) will be required to meet English language proficiency requirements, unless can provide proof of English proficiency acceptable to the Council.

## English Language Proficiency acceptable to the Council with demonstrated evidence, will be evaluated on a case-by-case basis, and may include the following:

- 1. Medical Graduates studying abroad who re-enter Canada from locations of training where instruction was received in English, as verified by the institution of instruction; **or**
- 2. International Medical Graduates who have received primary and/or secondary medical training instruction in English, as verified by the institution of instruction; **or**
- 3. A physician who has completed a Fellowship of at least one year within a country identified on the FMRAC list of countries as having English as a first or native language, as verified by a supervisor at the location of the Fellowship; **or**
- 4. Any physician who has successfully completed an English Language Proficiency exam beyond the expiry period, but has been working in an English-speaking environment, as verified by a supervisor at the location of employment.
