

The Executive Committee of the College of Physicians and Surgeons directs that, pursuant to section 47.6 of **The Medical Profession Act, 1981**, the Discipline Committee hear the following charges against Dr. Amjad Ali, namely:

1. You Dr. Amjad Ali are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(m) and/or Section 46(o) and/or section 46(p) of **The Medical Profession Act, 1981** s.s. 1980-81 c. M-10.1 and/or bylaw 8.1(2)(b)(i).

The evidence that will be led in support of this charge will include some or all of the following:

- (a) On or about January 18, 2013, the Council of the College of Physicians and Surgeons suspended you from the privileges of a duly qualified medical practitioner until March 23, 2013 pursuant to section 54(1)(b) of **The Medical Profession Act, 1981**;
- (b) On or about March 22, 2013, the Council of the College of Physicians and Surgeons suspended you from the privileges of a duly qualified medical practitioner until the close of the June, 2013 Council meeting pursuant to section 54(1)(b) of **The Medical Profession Act, 1981**;
- (c) On or about the 15<sup>th</sup> day of April, 2013 you completed a document entitled "Form R – Renewal – Application for Renewal of an Authorization to possess Marihuana for Medical Purposes" for L. C.;
- (d) At the time that you completed form R you were suspended from the privileges of a duly qualified medical practitioner;
- (e) In completing Form R you referred to yourself as "Dr. Amjad Ali";
- (f) In completing Form R you completed the following declaration:

I declare that I am the treating medical practitioner of the individual making this renewal application for an Authorization to Possess under the *Marihuana Medical Access Regulations* and that there have been no changes to the information provided in the last declaration signed by me.

- (g) You requested and received payment of \$500 in cash to complete the form;
- (h) Your actions constituted a breach of the suspension imposed upon you by the Council;
- (i) Your declaration that you were the "treating medical practitioner" for L. C. inaccurately described your status with the College of Physicians and Surgeons.

2. You Dr. Amjad Ali are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of **The Medical Profession Act, 1981** s.s. 1980-81 c. M-10.1 and/or bylaw 8.1(2)(b)(iii).

The evidence that will be led in support of this charge will include the following:

- (a) On or about the 15<sup>th</sup> day of April, 2013 you completed a document entitled "Form R – Renewal – Application for Renewal of an Authorization to possess Marihuana for Medical Purposes" for L. C.;
  - (b) You requested and received payment of \$500 in cash to complete the form.
3. You Dr. Amjad Ali are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) of **The Medical Profession Act, 1981** s.s. 1980-81 c. M-10.1.

The evidence that will be led in support of this charge will include the following:

- (a) On or about March 22, 2013, the Council of the College of Physicians and Surgeons suspended you from the privileges of a duly qualified medical practitioner until the close of the June, 2013 Council meeting pursuant to section 54(1)(b) of **The Medical Profession Act, 1981**;
  - (b) On or about the 15<sup>th</sup> day of April, 2013 you completed a document entitled "Form R – Renewal – Application for Renewal of an Authorization to possess Marihuana for Medical Purposes" for L. C.;
  - (c) You provided L. C. with a piece of paper which contained two telephone numbers for you and encouraged him to refer individuals who were seeking authorization to possess marihuana for medical purposes.
4. You Dr. Amjad Ali are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(m) and/or Section 46(o) and/or section 46(p) of **The Medical Profession Act, 1981** s.s. 1980-81 c. M-10.1 and/or bylaw 8.1(2)(b)(i).

The evidence that will be led in support of this charge will include some or all of the following:

- (a) On or about January 18, 2013, the Council of the College of Physicians and Surgeons suspended you from the privileges of a duly qualified medical practitioner until March 23, 2013 pursuant to section 54(1)(b) of **The Medical Profession Act, 1981**;
- (b) On or about March 22, 2013, the Council of the College of Physicians and Surgeons suspended you from the privileges of a duly qualified medical practitioner until the close of the June, 2013 Council meeting pursuant to section 54(1)(b) of **The Medical Profession Act, 1981**;
- (c) On or about the 27<sup>th</sup> day of March, 2013 you completed a document entitled "Form R – Renewal – Application for Renewal of an Authorization to possess Marihuana for Medical Purposes" for T. D.;
- (d) At the time that you completed form R you were suspended from the privileges of a duly qualified medical practitioner;
- (e) In completing Form R you referred to yourself as "Dr. Amjad Ali";
- (f) In completing Form R you completed the following declaration:

I declare that I am the treating medical practitioner of the individual making this renewal application for an Authorization to Possess under the *Marihuana Medical Access Regulations* and that there have been no changes to the information provided in the last declaration signed by me.

- (g) You received payment of \$400 in cash to complete the form;
- (h) Your actions constituted a breach of the suspension imposed upon you by the Council;
- (i) Your declaration that you were the "treating medical practitioner" for T. D. inaccurately described your status with the College of Physicians and Surgeons.

5. You Dr. Amjad Ali are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of **The Medical Profession Act, 1981** s.s. 1980-81 c. M-10.1 and/or bylaw 8.1(2)(b)(iii).

The evidence that will be led in support of this charge will include the following:

- (a) On or about the 27<sup>th</sup> day of March, 2013 you completed a document entitled "Form R – Renewal – Application for Renewal of an Authorization to possess Marihuana for Medical Purposes" for T. D.;

- (b) You requested payment of \$500 in cash to complete the form;
- (c) T. D. advised you that he had only \$400 available;
- (d) You received \$400 in cash from T. D. to complete the form.
