New Registration Bylaws

- Enacted September 19, 2014
- Are intended to align with National Standards
- Categories:
 - Regular (used to be Full),
 - Provisional
 - Ministerial (used to be Special)
 - Educational
 - Inactive
 - Podiatric Surgery Permits



Provisional

- Access provisional by having:
 - RCPS or CFPC eligibility; or
 - Pre- Licensure assessment
- All require supervision
- With eligibility may elect a pathway to Regular Licence:
 - RCPSC examination route;
 - CFPC certification without examination; or
 - Summative assessment route
 - Once pathway elected, it cannot be changed



What is different?

- No requirement to obtain LMCC part one until that becomes the minimum standard
- No requirement to practice or meet revalidation requirements or cycle to move from provisional to regular
- Have retained a Ministerial licence (Special)



Delegation from Physicians to Nurses

- Changes to the legislation provide authority to adopt bylaws that can allow physicians to delegate activities in College Bylaws to other Health Professionals.
- Bylaw based on the following principles:
 - Delegation will be from a particular physician to a particular registered nurse. Delegation will not be by category;
 - The activities which may be delegated are specified in bylaw;



Delegation principles continued

- When there is a specific program (Neonatal transport team etc.)
 which is identified, it is not necessary to identify the specific
 procedures that might be provided by the RN as part of the
 program;
- It will be the responsibility of the physician who delegates the activity to assess the RN's skill and knowledge to determine if, in the physicians' opinion, the RN has appropriate skill and knowledge to perform the delegated activity;
- Delegation must be in writing, except in the case of an emergency;
- The physician who delegates the authority to the RN must have a process in place to provide the appropriate supervision



Conscientious Objection Policy

- Lots of interest from public & physicians
- Controversial, with polarized views
- There will be a policy
- It will not pertain to Physician Assisted Death
- Several revisions; approval anticipated 09/15
- Expect physicians to arrange access to information and service



Policies and Guidelines

- There has been an effort over the past several years to update CPSS polices and guidelines on an ongoing basis and post on the website
- Over the last year changes to the following policies and guidelines have been made:
 - Patients who Threaten Harm to Themselves or Others
 - Role of Legal Counsel;
 - College Newsletter;
 - Contents and Access to Information in Physicians' College files;
 - Public Access to Council Meetings;
 - Public Inquiry about Investigation of Members



Prescription Drug Abuse - CPSS and FNIHB-SK

- Work with FNIHB-SK and Health Canada
 - expert resource to improve aspects of PDA;
 - Contribution Agreement signed for 5 years;
- Extension of the work of Prescription Review /Methadone programs;
 - Assist First Nations individuals/communities;
 initially four communities
- Focus: education, improve linkages, data
 - for practitioners, community workers, leaders



Infection Control Standards - Office

- New Standards and Guidelines coming;
- Adopted and adapted from the Public Health Ontario document; Infection Prevention and Control for Clinical Office Practice.

- Major areas of focus:
- Optimize Practice Excellence:
 - Improve Appropriate Assessment of physicians for Entry to Practice;
 - Enhance competency throughout Career Life cycle;
