The evidence that will be led in support of this charge will include some or all of the following:

- 1) You failed to respond in a timely way to communications from the CPSS in relation to College of Physicians and Surgeons file 005.2025.V.
- 2) You failed to respond to letters from the CPSS within 14 days as required by bylaw 16.2 and/or 16.2 in relation to CPSS file 005.2025.V.
- 3) You failed to cooperate with the CPSS when the CPSS was involved in a regulatory activity that involved you or your practice in relation to CPSS file 005.2025.V.
