Disposition:	Reprimand, 3-month suspension, undertaking and costs

The Council of the College of Physicians and Surgeons imposes the following penalties on Dr. Alexandre Yatsina pursuant to The Medical Profession Act, 1981:

- 1) The Council accepts Dr. Yatsina's undertaking, which has been provided to the Council, that he will enroll in and participate in the Physician Health Program of the Saskatchewan Medical Association and remain a participant in that program until either released of that obligation by the College of Physicians and Surgeons or the Physician Health Program concludes that there isn't a further benefit in his participation.
- 2) Pursuant to Section 54(1)(e) of *The Medical Profession Act, 1981*, the Council hereby reprimands Dr. Yatsina. The format of that reprimand will be in written format.
- 3) Pursuant to Section 54(1)(b) of the Act, the Council hereby suspends Dr. Yatsina for a period of 3 months commencing May 1, 2025 or such earlier date as Dr. Yatsina and the Registrar may agree to for the commencement of the suspension.
- 4) Pursuant to section 54(1)(i) of *The Medical Profession Act, 1981*, the Council directs Dr. Yatsina to pay the costs of and incidental to the investigation in the amount of \$10,932.00 payable on or before May 1, 2025.
- 5) Pursuant to section 54(2) of *The Medical Profession Act, 1981* the Council directs that Dr. Yatsina's licence will be suspended if the costs in paragraph 4) are not paid as required and that he will remain suspended until those costs are paid.
- 6) The Council reserves to itself the right to amend any of the terms of this penalty decision, upon application by Dr. Yatsina. Without limiting the authority of the Council, the Council may amend the effective date of the suspension provided for in paragraph 3) or the date for the payment of costs provided for in paragraph 4).
